↓ **IMPORTANT CONVENTION INFORMATION:**

- Registration is limited to 150 people - **Registrations are non-transferable** - Each registrant MUST have signed his/her registration form.
- Registrations will be accepted starting October 18, 2014. If more than 150 registrations are received by October 28, 2014, a random drawing will be held during the first week of November. If there are still spaces available after November 8, 2014 they will be processed in the order received.
- There is a limit of 4 registrations per envelope - Mail requiring signature for acceptance will be returned.
- **Registrants must be at least 13 years of age on or prior to September 17, 2015.**
- ALL CANCELLATIONS MUST BE IN WRITING VIA MAIL AND POSTMARKED NO LATER THAN May 25, 2015. A cancellation fee of \$40.00 will be charged per registration. Cancellations must be in writing and sent to: **N67 W 29280 Richter Rd., Hartland, WI 53029**. Any cancellation request postmarked after May 25, 2015, will not be entitled to a refund or a convention package or convention souvenirs.
- No refunds will be issued for any reason or at any time with respect to pre-paid convention related events, including but not limited to workshops or city excursions.
- **There will be a \$40 charge for any returned checks regardless of the amount of the check.**
- You will be notified of your acceptance into the convention via email upon verification of your information/payment and based on the registration process.
